Acceptance of the Terms of Use

These terms of use are entered into by and between you and Claritas, LLC (the “**Company**”, “**we**” or “**us**”). The following terms and conditions, together with any documents they expressly incorporate by reference, including the **Privacy Policy**, (collectively, these “**Terms of Use**”), govern your access to and use of Claritas.com, including any content, functionality, and services offered on or through Claritas.com (the “**Website**”), whether as a guest or a registered user.

Please read the Terms of Use carefully before you start to use the Website. By using the Website, you accept and agree to be bound and abide by these Terms of Use. If you do not want to agree to these Terms of Use, you must not access or use the Website.
